Appasaheb Birnale College of Pharmacy, Sangli, Maharashtra

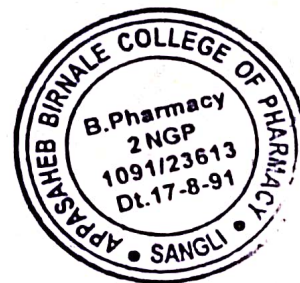
This Memorandum of Understanding (herein after called as the 'MoU') is entered into on this the 17th day of July 2023 by and between.

CLAUSE 1

CO-OPERATION

CLAUSE 2

- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party as and when required in teaching/ training methodology and suitably customize the curriculum so that the students will get quality education.
- 2.3 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.4 **Utilization of facilities:** First & Second Party allow instrumental facilities to the students of both parties on the emerging technologies in order to bridge the skill gap and make them industry ready.

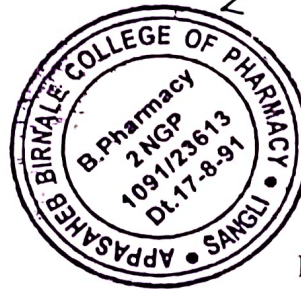
